Extended Day Program

Rates and Information

- Happy Hollow School's After-school Extended Day Program (3:00 to 5:00 p.m.) is available to students enrolled in the School's full-day programs.
- The Early Drop-off Extended Day Program (8:00 to 8:30 a.m.) is available to students enrolled in the School's full-day and half-day morning programs.
- The Extended Day Program is based on 37 school weeks and billed in monthly installments.
- Families who enroll in the Extended Day Program are contracting for participation in the program for the entire 2011-2012 school year.
- Any changes to enrollment may be made prior to the start of the school year or, if after the start of the school year, changes require 30 days prior notice of the change.
- The 2011-2012 Extended Day Program rates are set at \$7.00 per half hour per day.
- Occasional or emergency use of the Extended Day Program will be billed at \$14.00 per half hour per day. Happy Hollow School does not guarantee the availability of openings in the Extended Day Program for occasional or emergency use.
- We do not schedule coverage after 5:00 pm. Please note that any parent arriving to pick up their child after 5:00 pm will be billed a late charge of \$10.00 per every 5 minutes thereafter.

Families enrolled in the Early Drop-off Extended Day Program are requested to escort their child to the Lower School entrance. Families enrolled in the After-school Extended Day Program are requested to pick up their children via the Lower School entrance.
